Dear Prime Minister Morrison

On 2 November 2018, we wrote to you and included a copy of an Email, dated 13 October, 2018, "The Science is Clear" from Australia's Chief Scientist, Dr Alan Finkel. We also enclosed a copy of our letter, dated 15 February, 2017, addressed to then Prime Minister, Hon Malcolm Turnbull. Also enclosed was CNI FACT SHEET – CARBON DIOXIDE (CO₂). We now enclose copies of these.

Essentially, we documented:

- The futility of the emissions reduction commitment made at the December 2015 Paris Conference of the UNFCCC.
- The historic dishonesty of the Intergovernmental Panel on Climate Change (IPCC) manifested again at the December 2015 Paris Conference.
- The scientifically unsustainable statements by the Chief Scientist.
- All of the above justifies withdrawal from the Paris Agreement and cancellation of any further commitment to the UN Green Climate Fund; cancellation of emissions reduction commitment; cancellation of renewable energy targets (RET) across Australia; phasing out renewable energy subsidies; cancellation of the various energy and climate bodies; stopping the closure of coal fired power stations; support for the establishment of and if necessary, investment in clean coal technology coal fired power stations and for the upgrading of existing coal fired power stations to clean coal technology.

These policies, if adopted, would bring Australia's energy costs down towards the lowest level and restore international competitiveness and lift the level of economic activity and would stop the closure of Australian businesses and stop businesses going offshore. As pointed out by the Grattan Institute, in a submission on the proposed legislation, the revised energy "big stick" approach, "won't cut power bills and might well prove counter productive."

The Hon Steve Irons MP responded, on your behalf, under date of 16/12/2018. He reaffirmed Australia's commitment to emissions reduction and the Paris Agreement, stating it "is in the national interest, including our strategic interests in the Pacific. Australia is proud to stand on its record of meeting international commitments."

Contrast this with Australia's failure to meet its commitment to the International Energy Program (IEP Treaty) signed in 1979. As a member of the International Energy Agency

and signatory to the IEP Treaty, Australia is required “to hold oil stocks equivalent to at least 90 days of the previous year’s average daily net oil imports.”

Australia has not met its IEP Treaty obligations for several years. It was reported on the ABC on 23 January 2019 that Australia’s oil stocks had fallen to 50 days which is equivalent to 21 days petrol for automobiles, 18 days of diesel and 20 days of aviation fuel. Australia would grind to a halt in a week if our fuel imports were stopped, something that becomes more possible in the increasing geo political security tensions in the Indo-Pacific region.

Conclusion: Australia is willing to support a pointless commitment to the Paris Agreement on emissions reductions that is causing serious economic damage but fails to meet its obligations to the IEP Treaty, a failure which puts Australia at grave risk of total shutdown.

It should be noted that IPCC official, Ottmar Edenhofer, said in 2010 “...one has to free oneself from the illusion that international climate policy is environmental policy. Instead, climate change policy is about how we redistribute de facto, the World’s wealth.” And Kevin Trenberth, lead author of IPCC reports stated “None of the models used by the IPCC are initialized to the observed state and none of the climate states in the models correspond, even remotely, to the current observed state.”

These are just two of many historic quotes that show that IPCC and UNFCCC policies are about achieving a new world order and not about climate change or global warming.

If Labor wins the forthcoming Federal election it will be economically, industrially and socially disastrous for Australia. To avoid this we believe the Liberal/National Coalition must:

1. You, Mr Morrison, as Prime Minister must take all Australians into your confidence and concede that Australia has been deceived by the Paris Agreement and the failed IPCC claims and projections. You can then apologise for the skyrocketing electricity prices which have hurt so many people. You can then use the CNI FACT SHEET – CARBON DIOXIDE (CO₂) in an Australia wide and media wide educational campaign. This will convince Australians that we must withdraw from the Paris Agreement.
2. Tell all Australians that the Emissions Reduction Target, the RETs, the various climate and energy bodies and renewables subsidies will be phased out in a morally proper way, in the national interest
3. The savings of billions of dollars will be used to upgrade old and invest in new, clean coal technology coal fired power stations to guarantee a return to the World’s lowest and most reliable electricity prices. Surplus funds will be used in the national interest. Meeting Australia’s obligations under the IEP Treaty could be a priority.
4. Stress that the people who will benefit will be the ‘forgotten people’ that is the everyday Australians and small businesses, the backbone of the economy.

5. Then contrast this result with the aggravated and ongoing disaster of a Shorten Government's increased RET and resultant rocketing electricity prices and unreliability which will be seriously damaging to the very people that your policies will benefit.
6. Commit, with a positive achievable plan, to meeting Australia's obligations under the IEP Treaty and thus guarantee Australia's security in uncertain times.
7. Commit to promoting and supporting the development of coal to liquids technology.

Other Policy Initiatives

1. The Family

* Introduce a Family Impact Statement (FIS) as a public document which accompanies all legislation outlining any adverse impact on the family if the legislation is passed. The FIS will detail the steps to be taken to mitigate the adverse effects on the family.

* Remove discrimination against the single income family where one parent, mother or father, stays home to care for the children versus the two income family where the children are put into day care at the taxpayers' expense. In effect these single income families are paying tax to meet some of the child care costs of the two income family.

Australia should support these single income families earning less than \$150,000 per annum with tax relief and financial allowances as compensation for the financial sacrifices they make in raising the next generation of Australians. Mothers must have freedom of choice whether to continue in employment or to remain home to care for their new born child/children but research shows many mothers are forced into employment to supplement the family income to meet the family's day to day needs.

Longitudinal research shows that children, who are spared attendance at child care, particularly in the first three years of the child's life, achieve better at school and are more secure and confident in their outlook.

2. Sexualisation of children.

Find a way to ban Safe Schools Australia Coalition (SSCA) and Building Respectful Relations (BRR) programs from all Federal and State Curricula. These are fraudulently described as anti bullying and anti domestic violence programs respectively when they are simply a Marxist inspired sexualisation of children program. SSCA co-founder, Ros Ward, is on record as saying "*(It's) not about stopping bullying*" and "*(It's) about gender and sexual diversity. About same sex attractive, about being transgender, about being lesbian, gay bi-sexual...*" and "*(It's) part of a broader Marxist strategy to change society.*"

Find a way to stop the practice of children in schools being classed as mature minors and enabled to transgender without parental consent.

3. Domestic Violence – replace the SSCA and BRR by committing to the establishment of an Australia wide anti domestic violence education program throughout the whole community including public and private primary and secondary schools.

Ensure that all organizations, associations etc in receipt of taxpayer funds are obliged to have an anti domestic violence program, based on respect and to practice it. All other organizations, not in receipt of government funding, must be encouraged to establish and practice anti domestic violence programs.

4. Towards a more inclusive Australia.

Review and overhaul all welfare programs with a view to developing incentives for the welfare recipients to transition to a self supported life, where possible. This would include work for the dole; employment training/education partnerships with business and industry to transition unemployed to employed and a fair and balanced approach to loss of benefits that encourages welfare recipients to seek to become self supporting.

5. Drug Policy – Establish an Australia wide, community wide anti drug education program based on abstinence NOT on harm minimization. This program must reach into every facet of society with a strong thrust in primary schools and high schools. It must be ongoing and all sporting, community and other organizations receiving taxpayer funded support must have an operative anti drug program to qualify for continued support. In the national interest, all forms of the media could be required to provide a small percentage of their advertising time or space to this community wide program. This is a medium to long term program, that, if continued will, over a generation or two, move Australia towards a drug free society.

6. Cyber Security – National Security – Implement measures to control or prohibit foreign investment in and foreign support of Australia's university academic and research programs and involvement in student organizations and activities. This should be the starting point in a complete review and overhaul of Australia's security measures.

Prime Minister, please pardon the bold type but It is time for someone to stand up for everyday Australians and small and medium businesses and deliver affordable, low cost, reliable and secure electricity. Australians have been punished by the RET and Emissions Reduction policies. Australia is capable of doing better than current GDP of around 3% and falling. Let us all work together to get electricity prices down and create more jobs and more exports through our increased competitiveness at a benefit to the environment through increased levels of CO2 in the atmosphere.
